### 2. Hazard(s) Identification

**Classification:** Not classified as hazardous

**Label Elements:**

Not hazardous in accordance with the Globally Harmonized System for the Classification and Labeling of Chemicals (GHS).

**Supplemental Labeling:**

Prolonged exposure to elevated noise levels during operations may affect hearing. A greater hazard, in most cases, is the exposure to the dust/fumes from the material or paint/coatings being processed. Most of the dust generated during abrasive processing is from the base material or coatings and the potential hazard from this exposure must be evaluated.

### 4. First-Aid Measures

---

**Eyes:** Remove contact lenses if present and easy to do. Flush eyes thoroughly with large amounts of water, holding eyelids open. If irritation persists, seek medical attention.

**Skin:** Wash skin with soap and water. If irritation or other symptoms develop, seek medical attention.

Exposure to dust generated from processing the base material or coatings may present additional health hazards.

**Indication of immediate medical attention and special treatment, if necessary:** Immediate medical attention should not be required.

### 5. Fire-Fighting Measures

---

**Suitable (and unsuitable) extinguishing media:** Use any media that is suitable for the surrounding fire. Do not use water on fires involving metals dusts. Use an appropriate dry powder.

**Specific hazards arising from the chemical:** This product is not flammable or combustible; however, consideration must be given to the potential fire/explosion hazards from the base material being processed.

**Many materials create flammable/explosive dusts or turnings when machined or ground.**

**Special protective equipment and precautions for fire-fighters:** Firefighters should wear full emergency equipment and NIOSH approved positive pressure self-contained breathing apparatus.

### 5. Accidental Release Measures

---

**Personal precautions, protective equipment, and emergency procedures:** Wear appropriate respirator and protective clothing as needed to avoid eye contact and inhalation of dust.

**Environmental precautions:** Avoid contamination of water supplies and environmental releases. Report spills as required to authorities.

**Methods and materials for containment and cleaning up:** Carefully collect dry material, avoiding the creation of airborne dust. Place in a suitable container for disposal.

### 7. Handling and Storage

**Precautions for safe handling:** For industrial or professional use only. Avoid breathing dust. Use with adequate ventilation. Avoid eye and skin contact with grinding dust. Wear suitable gloves, eye protection and appropriate protective clothing according to the operation. Wash thoroughly after handling. Consider potential exposure to components of the base materials or coatings being ground. Refer to OSHA's substance specific standards for additional work practice requirements where applicable.

Most of the dust generated during abrasive processing is from the base material or coatings and the potential hazard from this exposure must be evaluated. This dust may present a fire or dust explosion hazard and may present a serious health hazard.

**Conditions for safe storage, including any incompatibilities:** No special storage required.

**Appropriate engineering controls:** Use with adequate general or local exhaust ventilation to maintain exposure levels below the occupational exposure limits.

#### Personal Protective Equipment:

**Respiratory protection:** Not necessary unless workplace concentrations of hazardous constituents exceed the exposure limits. If the exposure levels are excessive and irritation or other symptoms are experienced, an approved respirator should be worn. Consider the potential for exposure to components of the coatings or base material being ground in selecting proper respiratory protection. Most of the dust generated during grinding is from the base material being ground and the potential hazard from this exposure must be evaluated.
